

Subject: **IMPLEMENTATION OF PROCUREMENT ACTIVITIES PROCESS THROUGH EPADS**

Reference Ministry of Energy (Petroleum Division) letter No.Genl-1(1)/2023/IT/EPADS dated 6 September, 2024 on the subject noted above.

2. This Authority has developed the "e-Pak Acquisition & Disposal System", a comprehensive web-based software platform designed to manage the entire procurement process. PPRA has also notified regulation vide S.R.O. 296(I)/2023 dated 27<sup>th</sup> February, 2023 (S.R.O available at PPRA website. [www.ppra.org.pk/doc/epronotif1.pdf](http://www.ppra.org.pk/doc/epronotif1.pdf)) title "E-Pak-Procurement Regulation 2023" and instructed Procuring Agencies to carry out all their procurement activities of Petty Cash, RFQ, Open Competitive Bidding through EPADS. Any procurement process that takes place without utilizing EPADS will be constructed as mis-procurement in accordance with Rule-50 of Public Procurement Rules, 2004.
